



**ACCELRY'S SOFTWARE INC.  
Evaluation License Agreement**

BY SUBMITTING YOUR PERSONAL INFORMATION BY HITTING THE "SUBMIT" BUTTON, INSTALLING OR USING THE SOFTWARE OF ACCELRY'S SOFTWARE INC. ("ACCELRY'S"), YOU ARE CONSENTING TO BE BOUND BY AND IS BECOMING A PARTY TO THIS AGREEMENT.

**LICENSE GRANT.** During the Evaluation Term (as determined by Accelrys), Accelrys grants to Customer a nonexclusive license to use Accelrys' Accelrys Notebook ("Software") and accompanying documentation ("Documentation") in the manner described below under "Scope of License Grant."

**SCOPE OF LICENSE GRANT.** Customer may: download and install the Software, and use the Software on Customer's computer solely for evaluation purposes, ONLY if Customer has not previously evaluated or licensed the same version of the Software. Customer may not: disable or bypass the time limitation mechanism contained in the Software; modify, translate, reverse engineer, decompile, disassemble (except and solely to the extent an applicable statute expressly and specifically prohibits such restrictions), or create derivative works based on the Software; rent, lease, grant a security interest in, or otherwise transfer rights to the Software; or remove any proprietary notices or labels on the Software. This license does not entitle Customer to hard-copy documentation, support or telephone assistance.

**NO WARRANTY.** The Software and Documentation are provided "AS IS" and without any warranty. ACCELRY'S AND ITS SUPPLIERS DISCLAIM ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OR CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NONINFRINGEMENT OF THIRD PARTIES' RIGHTS. Some jurisdictions do not allow exclusions or disclaimers of warranties, so the above exclusions or disclaimers may not apply to Customer.

**TITLE.** Title, ownership rights, and intellectual property rights in the Software and Documentation shall remain in Accelrys and/or its suppliers. The Software is protected by copyright and other intellectual property laws and by international treaties. Accelrys reserves any and all rights not expressly granted under this Agreement.

**TERMINATION.** The evaluation license granted hereunder shall terminate at the end of the Term. The evaluation license granted hereunder shall automatically terminate sooner if Customer fails to comply with the limitations described herein or falsifies any of the personal information submitted to Accelrys. Customer may terminate this evaluation license at any time by ceasing all use of the Software and Documentation. Upon termination, Customer must destroy all copies of the Software and Documentation.

**EXPORT CONTROLS.** The Software and related technology may not be exported or re-exported to (i) any country (or a national or resident thereof) to which the U.S. has embargoed goods; or (ii) anyone on U.S. Commerce Department's lists to whom a transaction is prohibited. Customer further represents and warrants that Customer is not located in, under the control of, or a national or resident of any such country or on any such list. In addition, Customer agrees to comply with any other applicable U.S. export control laws and any local laws in Customer's jurisdiction that may impact Customer's right to import, export, or use the Software.

**LIMITATION OF LIABILITY.** UNDER NO CIRCUMSTANCES SHALL ACCELRY'S OR ITS SUPPLIERS OR RESELLERS BE LIABLE TO CUSTOMER OR ANY OTHER PERSON FOR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, INCLUDING WITHOUT LIMITATION, DAMAGES FOR LOST PROFITS OR REVENUE, BUSINESS INTERRUPTION, LOSS OF DATA, COMPUTER FAILURE OR MALFUNCTION, WHETHER FORESEEABLE OR NOT. IN NO EVENT WILL ACCELRY'S BE LIABLE FOR ANY DAMAGES IN EXCESS OF THE AMOUNT ACCELRY'S RECEIVED FROM CUSTOMER FOR A LICENSE TO THE SOFTWARE, EVEN IF ACCELRY'S SHALL HAVE BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY THIRD PARTY. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THIS EXCLUSION AND LIMITATION MAY NOT APPLY TO CUSTOMER IN ITS ENTIRETY.

**U.S. GOVERNMENT END USERS.** The Software is a "commercial item" as that term is defined at 48 C.F.R. 2.101, consisting of "commercial computer software" and "commercial computer software documentation" as such terms are used in 48 C.F.R. 12.212. Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227.7202-1 through 227.7202-4, all U.S. Government end users acquire the Software with only those rights set forth therein.

**GENERAL.** This Agreement represents the complete agreement concerning the Evaluation license granted hereunder and may be amended only by a writing executed by both parties. If any provision of this Agreement is held to be unenforceable, such provision shall be reformed only to the extent necessary to make it enforceable. This Agreement shall be construed, governed, and enforced solely and exclusively by the law of the State of California, USA, excluding conflict of law provisions. The United Nations Convention on Contracts for the International Sale of Goods will not apply. Customer hereby agrees that the courts located in the State of California, USA, will constitute the sole and exclusive forum for the resolution of any and all disputes arising out of or in connection with this Agreement and Customer hereby irrevocably consents to the personal jurisdiction and venue of such courts and irrevocably waives any objections thereto. Customer may not assign this Agreement to any third party without first obtaining the express written consent of Accelrys and any assignment by Customer without such consent shall be null and void. Accelrys may freely assign this Agreement to any third party.
